### Plastic Seating:

#### A) Product Material:

- 1) Average thickness of material to exceed .20" or greater.
- 2) Waterproof and rust proof.
- 3) Fully compounded color (not dry blended) with UV light stabilizer to increase longevity of color retention in direct sunlight applications.
- 4) Suitable for both indoor and year-round outdoor use.
- 5) 100% recyclable.
- 6) Products tested to 750 lbs. static load on the seating surfaces. Drift tested to 250 lbs, Dash & Swerve Benches tested to 1000 lbs, Twisted Hex tested to 250 lbs, Elevate Tiered Seating tested to 500 lbs. per seat. Shayz lounge tested to 250 lbs.
- 7) Rubber legs on hard plastic products are Santoprene material and are considered a non-warranty replacement item that are intended to wear as they provide floor protection in indoor and outdoor spaces.

#### B) Metal Frame Materials:

- 1) Powder coated steel frames pass ASTM B117-16: No visual evidence of corrosion at the end of 1000 hours of exposure to salt spray corrosion testing. Performed in a salt spray chamber using a 5% +/-1% salt solution at 95°F +/-3°F.

#### C) Compact Laminate (a.k.a. Phenolic) Material:

- 1) All-weather performance in all climates. Impervious to moisture and bacteria.
- 2) Damaging UV rays a 99% filtered for longer color retention.
- 3) Zero edge banding.
- 4) Includes threaded inserts permanently installed into the material for easy assembly.

#### D) Emissions: Session Series hard plastic seating is compliant with:

- 1) ANSI/BIFMA X7.1-2011 7-day emission limits for seating. <sup>[1]</sup><sub>[SEP]</sub>
- 2) ANSI/BIFMA e3-2014 Furniture Sustainability Standard Sections 7.6.1, 7.6.2, and 7.6.3 for seating.

- 5) Waterproof Cushions = 1 Year Limited Warranty
- 6) Clean with Dawn® dish soap and water, Formula 409®, Fantastik®, Windex®, and Scrubbing Bubbles®. Disinfect Bleach 1:9 ratio of bleach to water, Dispatch® 1:10 dilution, hydrogen peroxide, CaviWipes®, BioWipes®, Coverage Plus Germicidal Wipes®, Glance NA® Diluted 1:50
